Paper –I (200 Marks): Duration: 2 Hrs.

- Current events of national and International importance.
- History of India and Indian national movement.
- Indian and World Geography – physical, social, economic geography of India and the world.
- Indian Polity and governance – Constitution, Political System, Panchayath Raj, Public Policy, Rights Issues, etc.
- Economic and Social development – Sustainable development, Poverty, inclusion, demographics, social sector Initiatives, etc.,
- General Issues on environmental ecology, bio-diversity and climate change – that do not require subject specialization.
- General Science.

Paper – II (200 Marks) – Duration: Two Hrs.

Comprehension

- International skills including communications skills.
Logical Reasoning and analytical ability.
- Decision making and problem solving.
- General Mental Ability
- Basic Numeracy (Numbers and their relation, orders of Magnitude etc., (Class X level), Data Interpretation (Charts, Graphs, Tables, Data sufficiency etc., - Class X Level).
- English Language comprehension skills (Class X Level).

CIVIL SERVICES MAINS EXAM SYLLABUS

The Written examination will consist of the following papers:

PAPER A - English 300 Marks – Qualifying Nature – Marks not counted – Passing mandatory.

The aim of the paper is to test the candidate's ability to read and understand serious discursive prose, and to express his ideas clearly and correctly, in English and Indian Language concerned.

Paper B – A – Modern Indian Language 300 Marks – Qualifying Nature – Marks not counted (30% passing mandatory)

- i. Comprehension of given passages
- ii. Precise Writing
- iii. Usage and Vocabulary
- iv. Short Essay
- v. Translation from English to the Indian Language and vice – versa.

Note 1: The Papers on Indian Languages and English will be of Matriculation or equivalent standard and will be of qualifying nature only. The Marks obtained in these papers will not be counted for ranking.

Note 2: The candidates will have to answer the English and Indian Languages papers in English and the respective Indian Language (Except where translation is involved).

PAPER -1

Essay -250 Marks – To be written in the medium or Language of the Candidate's choice – Candidates will be required to write an essay on a specific topic. The choice of subjects will be given. They will be expected to keep closely to the subject of the essay to arrange their ideas in orderly fashion, and to write concisely. Credit will be given for effective and exact expression.

PAPER –II

General Studies – I 250 Marks (Indian Heritage and culture, History and Geography of the World and Society)

Indian Culture will cover the salient aspects of Art Forms, Literature and Architecture from ancient to modern times.

Modern Indian History from about the Middle of the eighteenth century until the present – significant events, personalities, issues.

The freedom Struggle – its various stages and important contributors / contributions from different parts of the country.

Post – Independence consolidation and reorganization within the country.

History of the world will include events from 18th Century such as industrial revolution, World Wars, redrawing of National boundaries, colonization, decolonization, political philosophies like communism, capitalism, socialism etc., - their forms and effect on the society.

Salient features of Indian Society, Diversity of India.

Role of Women and Women's organization, population and associated issues, poverty and developmental issues, urbanization, their problems and their remedies.

Comparison of the Indian constitutional scheme with that of other countries Parliament and State Legislatures – structure, functioning, conduct of business, powers & privileges and issues arising out of these.

Structure, organization and functioning of the Executive and the Judiciary Ministers and Departments of the Government; pressure groups and formal/informal associations and their role in the Polity.

Salient features of the Representation of People's Act.

Appointment to various Constitutional posts, powers, functions and responsibilities of various Constitutional Bodies.

Statutory, regulatory and various quasi – judicial bodies Government policies and interventions for development in various sectors and issues arising out of their design and implementation.

Development processes and the development industry the role of NGOs, SHGs, various groups and associations, donors, charities, institutional and other stakeholders Welfare schemes for vulnerable sections of the population by the Centre and States and the performance of these schemes; mechanisms, laws, institutions and Bodies constituted for the protection and betterment of these vulnerable sections.

Ethics and Human Interface: Essence, determinants and consequences of Ethics in human actions; dimensions of ethics; ethics in private and public relationships.

Human Values – lessons from the lives and teachings of great leaders, reformers and administrators; role of family, society and educational institutions in inculcating values.

Attitude: Content, structure, function; its influence and relation with thought and behaviour; moral and political attitudes; social influence and persuasion.

Aptitude and foundational values for Civil Service, integrity, impartiality and non-partisanship, objectivity, dedication to public service, empathy, tolerance and compassion towards the weaker-sections.

Emotional intelligence – concepts, and their utilities and application in administration and governance.

Contributions of moral thinkers and philosophers from India and world.
